APPLICATION PROCEDURES FOR MEMBERSHIP

1. Two(2) sponsors shall be named on the Application. Sponsors must be Club members from two (2) different families. The Application is to be accompanied by letters of recommendation from each sponsor who shall have been members for at least one (1) year. In addition, member parent or member grandparent for Class D applications must sponsor the Applicant.
2. Applicant(s) shall complete and sign the Application.
3. Sponsors shall submit the Application to the Club Secretary through the Club office.
4. When a completed Application has been received, the Secretary shall:
 - a. Submit the Application to the Chairman of the Membership Committee who shall indicate on the Application, recommendation or non-recommendation for membership.
 - b. Post the name and address of the Applicant(s) on the Club bulletin board for a period of at least one (1) week prior to a meeting of the Governing Board.
5. The Governing Board shall act upon the Application at its next regular meeting by a written ballot.
6. The Secretary shall notify the Applicant(s) of election to the Club membership, and the Applicant shall formally become a member upon payment of the required membership fee.
